- o International - Greenpeace, Amnesty International, Movember, UNHCR
- o National - Heart Foundation, Cancer Council, RNIB, & Peak Bodies.
- o State - Health, Education, Community Banks, Environment.
- o Community - Targeted Causes & Locations

## COMMERCIAL BOARDS

- o Public Companies - Strategy, Risk & Governance
- o Private Businesses - often relationship focused
- o Family Companies - political nose is key
- o Start up's - sexy and in high demand.
- o Investment/Equity Boards - beware!


## COMMERCIAL, PUBLIC OR NFP?

## 1. HOW MUCH CAN YOU BE PAID?

Listed Chair: \$132,000	Listed Director: \$82,500
Unlisted Chair: \$70,985	Unlisted Director: \$41,606
Private Chair: \$61,800	Private Director: \$ 41,200
NFP Chair: \$41,200 (if paid)	NFP Director: \$20,100 (if paid)

- Half of ASX 100 and a quarter of ASX 250 companies pay additional fees to main board committees members;
  - 85% - 96% of Not for Profits are unpaid.
